### **Call to Order**

Chairman Butch Kirven

By a roll call vote of seven for Councilor Meadows (Dill, Barnes, Meadows, Shaw, Harrison, Tzouvelekas and Tripp) and five for Councilor Seman (Norris, Seman, Fant, Ballard and Kirven), Councilor Meadows was elected County Council Chairman.

**Item (5)     Transferring of the Gavel**

Councilor Kirven passed the gavel to Chairman Meadows.

**Item (6)     Election of Council Vice-Chairman**

Chairman Meadows opened the floor for nominations for County Council Vice-Chairman.

Councilor Dill stated he had initially expressed an interest in serving as County Council Vice-Chairman; however, he was convinced that Councilor Tripp was the ideal candidate for the seat, given his years of experience in the State House and in the business world.

**Action:** Councilor Dill nominated Councilor Tripp for County Council Vice-Chairman.

**Action:** Councilor Seman nominated Councilor Ballard for County Council Vice-Chairman.

**Action:** Councilor Seman moved to close nominations.

Motion to close nominations carried unanimously.

By a roll call vote of seven for Councilor Tripp (Dill, Barnes, Meadows, Shaw, Harrison, Tzouvelekas and Tripp) and five for Councilor Ballard (Norris, Seman, Fant, Ballard and Kirven), Councilor Tripp was elected County Council Vice-Chairman.
