**Item (7)**                    **Public Hearings**

**a.      Dunklin Fire District / Millage Increase**

A public hearing was held for the purpose of receiving comments from the public regarding a resolution to provide for the millage rate to be levied by the Dunklin Fire District.

There being no speakers, Councilor Kirven declared the public hearing closed.

**b.      Boiling Springs Fire District / Continuation of Millage**

A public hearing was held for the purpose of receiving comments from the public regarding a resolution to provide for continuation of current ad valorem property tax to be levied by the Boiling Springs Fire District.

**c.      South Greenville Fire District / Continuation of Millage**

**d.      Fairmont Avenue / Transfer of County Owned Property**

A public hearing was held for the purpose of receiving comments from the public regarding an ordinance authorizing the transfer of approximately 15 acres of real property located off Fairmont Avenue in Greenville County identified as Greenville County Tax Map numbers 0387.00-01-004.00, 0387.00-01-004.03, and 0387.00-01-004.01 by way of Federal American Rescue Plan Act Funding to the Greenville County Redevelopment Authority, and to authorize the execution of a deed and any other documents and agreements related thereto.

**Action:** Councilor Kirven moved for adoption a resolution to provide for continuation of current ad valorem property tax to be levied by the South Greenville Fire District and the Boiling Springs Fire District.

**c. Gentherm Corporation and Gentherm Automotive, LLC (Project Circle K Holdings) / Consent to Transfer and Assignment**

**Action:** Councilor Kirven moved for adoption resolution approving, ratifying and consenting to the transfer and assignment by Gentherm (South Carolina) Corporation (f/k/a Alfmeier Corporation) and Gentherm Automotive, LLC (f/k/a Alfmeier Friedrichs and Rath LLC) to, and assumption by, Circle K Holdings LLC of a certain existing FILOT agreement to which the County was a party and other matters related thereto.

2. *Place a maximum height on the dwellings of two story or 35 ft in total height*
3. *Submit a Final Development Plan for review and approval prior to the issuance of any land development or building permits*

Motion to amend carried unanimously.

**Action:** Councilor Fant moved approval of the ordinance as amended.

**c.     Metropolitan Sewer Subdistrict / Boundary Enlargement**

**Action:**                    Councilor Seman moved for approval at second reading an ordinance authorizing the enlargement of the territory of the Metropolitan Sewer Subdistrict and other matters relating thereto.

**Action:**                    Councilor Seman moved to hold the item until the November 5 County Council meeting at such time the public hearing was scheduled.

**Item (12)**                    **Ordinances – First Reading**

**a.     Zoning Ordinances**

Councilor Fant presented for first reading Zoning Dockets **CZ-2024-066** through **CZ-2024-069**.

Chairman Tripp referred the items to the Planning and Development Committee.

**b.     Greenville / Anderson Multi County Industrial Park Agreement Amendment (2010 Park) – Project Palmetto (Anderson County)**

Councilor Kirven presented for first reading an ordinance to amend an agreement for the development of a joint county industrial and business park (2010 Park) of Anderson and Greenville Counties so as to enlarge the park.

Chairman Tripp stated the item would remain on the floor.

**c.     Sale of County Owned Property – 6 Bailey Mill Road**

Councilor Kirven presented for first reading an ordinance to authorize the sale of a county-owned 1.995-acre parcel of real property located at 6 Bailey Mill Road, Travelers Rest, at the corner of Highway 14 and Bailey Road; and to authorize the Chairman of County Council and the County Administrator to execute appropriate deeds and agreements related thereto.

Chairman Tripp stated the item would remain on the floor.

**d. Unified Development Ordinance**

As noticed in the Council packet, Councilor Seman presented for first reading an ordinance to adopt the Greenville County Unified Development Ordinance.

Chairman Tripp referred the UDO to the Planning & Development Committee and requested that the Planning Commission discuss the UDO at its next meeting and provide a recommendation.

**Item (13) Committee Reports**

**a. Committee of the Whole**

**i. Council Rules Amendment – County Council Employees**

**Action:** As noticed in the Council packet, Councilor Seman moved to suspend Council Rules VI (A) to allow for the immediate adoption of a Council Rules Amendment.

Motion to suspend carried unanimously.

**Action:** Councilor Seman moved to add new subsection (E) to Section II to require a three-fourths vote of the Members of Council to hire the three named Council employees; a three-fourths vote of the Members of Council to terminate a Council employee without cause; and provide for a majority vote of the Members of Council to terminate for cause.

Motion carried unanimously.

**ii. ~~Interim~~ County Attorney Appointment**

**Action:** Councilor Seman moved to authorize the Chairman of County Council to negotiate and execute a contract with Christopher Antley for the position of County Attorney under the terms discussed in executive session.

Motion carried unanimously.
