TOGETHER with all and singular the Rights, Members, Hereditaments and Appurtenances of incident or appertaining.

TO HAVE AND TO HOLD, all and singular the said Premises before mentioned unto the said subject, however, to the limitations and conditions hereinbefore imposed.

And it does hereby bind itself and its successors in office to warrant and forever defend all its Heirs and Assigns, against itself and its successors in office and against every other person whoms or any part thereof.
