acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said

D.H. Traxler, All that piece, parcel or lot of land situate on North Main Street, in the City of Greenville, State and County aforesaid, and having the following metes and bounds, to-wit:

Beginning at corner of lot of H.J. Haynsworth, thence N. 72 W. 248-9/10 feet to a stake; thence S. 18 W. 87-1/2 feet to a stake; thence S. 72 E. 248-9/10 feet to a stake on Main Street; thence with said Main Street N. 18 E. 87-1/2 feet to the beginning corner.

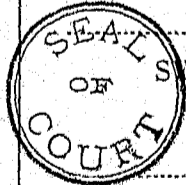
