(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said T.M. Westbrook, all that certain piece, parcel and lot of land situate, lying and being in the State and County aforesaid, near Monaghan Mills, said lot is known as Lot No. 15 on the plat of New Hope, said lot has a frontage of 60 feet on Cobb St. and a depth of 150 feet more or less, Plat recorded in the R.M.C. office in and for Greenville Co., Plat Book A. page 307.
