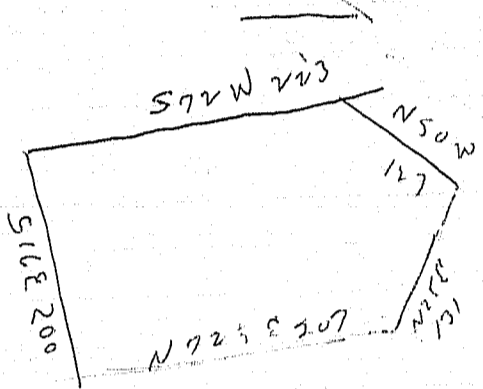


W.T. Jones Deed TO W.P. Jones

KNOW ALL MEN, BY THESE PRESENTS, That **I, W.T. Jones, of Simpsonville, Greenville County.** in the State aforesaid  
in consideration of the sum of **Two hundred and fifty** Dollars,  
to **me** in hand paid at and before the sealing of these presents by \_\_\_\_\_ (the receipt whereof is hereby

**W.P. Jones of Simpsonville, Greenville County** acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said **W.P. Jones, a certain piece, parcel or lot of land situated, lying and being in the Town of Simpsonville, Greenville County and State aforesaid on what is known as the Old Stage Road leading from the City of Greenville to Laurence:**  
**Beginning at stone on said road 3X; thence S. 72 W. 223 feet to a stone 3X; thence S. 16 E. 200 feet to a stone 3X; thence N. 72 1/2 E. 207 to a stone 3X; thence N. 25 E. 131 feet to a stone in center of said road 3X; thence up said road N. 50 W. 127 feet to the beginning stone, containing 1 1/4 acres, be the same more or less, bounded by lands of W.T. Jones, R.H. Alverson and others.**



TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in any-wise incident or appertaining.

TO HAVE AND TO HOLD, all and singular, the said premises before mentioned unto the said \_\_\_\_\_ heirs and assigns, forever.

AND **I** do hereby bind **myself, my** \_\_\_\_\_ heirs, executors and administrators, to warrant and forever defend all and singular the said premises unto the said **W.P. Jones, his** \_\_\_\_\_

heirs and assigns, against **me** and **my** \_\_\_\_\_ heirs, and against every person whomsoever lawfully claiming or to claim the same, or any part thereof.
