

A.N. Cathcart Deed TO J.E. Burden, STATE OF SOUTH CAROLINA, COUNTY OF Greenville

KNOW ALL MEN BY THESE PRESENTS, That I, A.N. Cathcart, of Laurens County, and

in consideration of the sum of One hundred and no/100 Dollars, to me in hand paid at and before the sealing of these presents by

J.E. Burden (the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said J.E. Burden, his heirs and assigns, all that piece, parcel or lot of land situate, lying and being about two miles West of Greenville Court House, in Greenville Township, near the Monaghan Mills and having the following metes and bounds to wit:

Beginning at a stake on Cobb Street, corner of Lot No. 4 and running; thence with Line of Lot No. 4, N. 12-44 E. 131.3 feet to an iron pin on line of lot No. 2; thence with line of Lot No. 2, N. 82 W. 52.5 feet to a stake, corner of Lot No. 6; thence with line of Lot No. 6, S. 12-44 W. 129.4 feet to an iron pin on Cobb Street; thence along line of Cobb Street S. 80 E. 52.5 feet to the beginning corner, and being known as lot No. 5, according to a plat prepared by R.E. Dalton, on June 7th, 1910 and recorded in R.M.C. Office for Greenville County in Plat Book "A" at page 409. Being the same lot of land conveyed to me, the said A.N. Cathcart by J.E. Burden, by deed dated 31st, day of December 1909 and recorded in the R.M.C. office for Greenville County in Volume 5 of Deeds at page 471.
