Munn, her heirs and assigns, all my right, interest and title in and to all that certain piece, parcel or lot of land situate, lying and being in the City of Greenville County and State aforesaid, being all the other land which I now own of the lot conveyed to me by Samuel Stradley January 28th, 1910 on the West side of the spur track of the Greenville and Columbia Railroad; this plot of land being bounded by the lot which I conveyed to W.P. Conyers and T.C. Gower, the Cowser lot and the remaining part of the Stradley lot now owned by me; the said plot of land being a part of a lot conveyed to me by Samuel Stradley January 28th, 1910 and conveyed to Samuel Stradley by Mary C. Carpenter, 1875. X

AND I do hereby bind myself, my heirs, executors and administrators, to warrant and forever defend all and singular the said premises unto the said Aurelia T. Munn, her

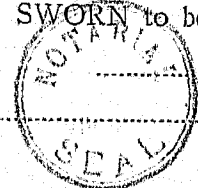
heirs and assigns, against me and my heirs, and against every person whomsoever lawfully claiming or to claim the same, or any part thereof.
