in the State aforesaid in consideration of the sum of Five thousand and four hundred (\$5400.) Dollars to me in hand paid at and before the sealing of these presents by

J. Perry Poole (the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said

J. Perry Poole, all that certain lot or parcel of land in said County and State in Greenville City, on South side of Washington Street:

Beginning at iron pin on said Street at corner of lot formerly belonging to Dean; thence S. 23-1/2 W. 217-1/2 feet to iron pin; thence S. 66-1/2 E. 68 feet to an iron pin; thence N. 23-1/2 E. 217-1/2 feet to iron pin on Washington Street; thence with South side of Washington Street N. 66-1/2 W. 68 feet to the beginning corner, being same lot conveyed to me by Mrs. Willie C. Williams, September 2nd, 1910, recorded in R.M.C. Office Vol. 6, page 192, reference to which is hereby craved.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in any-wise incident or appertaining.

AND I do hereby bind me & my heirs, executors and administrators, to warrant and forever defend all and singular the said premises unto the said J. Perry Poole, his

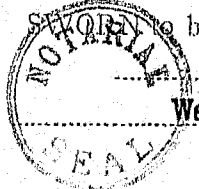
heirs and assigns, against me and my heirs, and against every person whomsoever lawfully claiming or to claim the same, or any part thereof.
