KNOW ALL MEN BY THESE PRESENTS, That I, S.J. Wilson, of Simpsonville, Greenville County...

in the State aforesaid in consideration of the sum of One hundred and fifty Dollars to me in hand paid at and before the sealing of these presents by...

Dr. A.S. Howard of Simpsonville, Greenville County (the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said

Dr. A.S. Howard a certain piece, parcel or lot of land situate, lying and being in the Town of Simpsonville in Greenville County and State aforesaid on the East side of the Greenville and Laurens R.R.:

Beginning at stone on South side of Trade Street near Cherry Tree 3X; thence S. 77-1/2 E. 123 feet & 2 inches to stone near the crossing said Street and Hedge Street 3X; thence S. 13-1/2 E. 140 feet 6 inches west of said Street to iron pin 3X; thence S. 82-1/2 W. 132 feet to iron pin 3X; thence N. 13-1/2 W. 135 feet 6 inches to the beginning stone on South side of Trade Street, containing 2084 square yards, be the same more or less, bounded by lands of J.H. Goodwin and others.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in any-wise incident or appertaining.

TO HAVE AND TO HOLD, all and singular, the said premises before mentioned unto the said Dr. A.S. Howard, his heirs and assigns forever.

AND I do hereby bind myself, my heirs, executors and administrators, to warrant and forever defend all and singular the said premises unto the said Dr. A.S. Howard, his

heirs and assigns, against me and my heirs, and against every person whomsoever lawfully claiming or to claim the same, or any part thereof.
