KNOW ALL MEN BY THESE PRESENTS, That I, M.E. Garrett of Greenville, S.C.

in the State aforesaid in consideration of the sum of One thousand fifty and seventy-five one hundredths Dollars to me in hand paid at and before the sealing of these presents by

T.A. Kellett (the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said

T.A. Kellett, all that lot or parcel of land lying, being and situate in Fairview Township, County and State aforesaid, containing twenty-eight and two one hundredths acres, more or less, being a part of the land conveyed to me by J.W. Peden on the fifth day of Jan. 1906, and recorded in Vol. V.V.V. page 107 in Register Mesne Conveyance office of Greenville S.C. and hath the following metes and bounds to wit, bounded by lands of J.W. Peden, W.M. Thomason and others:

Commencing on center of Bridge across road leading from Fountain Inn to Fork Shoals, running; thence N. 65-1/2 W. 25.04 to a stone X; thence S. 29-1/2 W. 9.76 to a stone 3X; thence S. 67 E. 5.50 to poplar 3X; thence S. 64-1/2 E. 2.50 to a stone 3X; thence S. 31-1/2 E. 4.65 to a stone 3X; thence S. 64-1/2 E. 3.00 to a stone; thence N. 42 E. 1.13 to a stone 3X; thence S. 35-1/2 E. 8.00 to a stone 3X; thence N. 37-1/2 E. 15.50 to beginning corner.
