KNOW ALL MEN BY THESE PRESENTS, That I, Mary L. Pack, of Greenville County and State
aforesaid in the State aforesaid
Dollars

in consideration of the sum of Four hundred and fifty dollars.
to me in hand paid at and before the sealing of these presents by Henrietta Anderson, of Greenville County and State aforesaid (the receipt whereof is hereby

acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said
Henrietta Anderson, all that piece, parcel or tract of land situate, lying and being in the
County of Greenville and State aforesaid, in what is known as Stradleyville near the City
of Greenville, adjoining lands of the Estate of Jonas Poore, being lot No. four as will
appear from a plat made May 8th, 1899 by J.N. Southern, D.S. and recorded in R.M.C.'s
office for Greenville County in Plat Book A. at page 251, and having the following metes and
bounds, to-wit:

Beginning at a stake at the corner of Lots No.'s three and four on the said Poore land
thence N. 67 W. 90 feet to a stake; thence N. 22-3/4 E. 68 feet to line of lot No. six;
thence S. 67 E. 90 feet to iron pin on the Poore land; thence along said Poore land to the
beginning corner 68 feet, being part of a lot purchased by me from Jonas Poore, December
15th, 1898, and recorded in Vol. FFF, page 262 in office R.M.C. for Greenville County, a more
detailed description will appear by reference to the above mentioned plat.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in any
wise incident or appertaining.

TO HAVE AND TO HOLD, all and singular, the said premises before mentioned unto the said Henrietta Anderson, her heirs and assigns forever.

forever defend all and singular the said premises unto the said Henrietta Anderson, her

heirs and assigns, against me and my heirs, and against every person whomsoever lawfully
claiming or to claim the same, or any part thereof.
