

T.H. Brockman DEED TO Frank Forrest

KNOW ALL MEN BY THESE PRESENTS, That I, T.H. Brockman

in the State aforesaid in consideration of the sum of Two hundred Dollars to me in hand paid at and before the sealing of these presents by

Frank Forrest (the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said

Frank Forrest all that piece, parcel or lot of land situate in the County and State aforesaid, in or near the town of Greer, having the following description:

Beginning at a point on Fairview Ave. and runs; thence along line of Lot No. 3, Block 3, of a plat of land recorded in the R.M.C. office for said County in Plat Book A. 176.7; thence at right angles to Zimmerman line; thence along his line 165.7 to said Ave.; thence with said Ave. 56.2 to the beginning corner.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in any-wise incident or appertaining.

TO HAVE AND TO HOLD, all and singular the said premises before mentioned unto the said Frank Forrest, his heirs and assigns forever.

AND I do hereby bind myself, my heirs, executors and administrators, to warrant and forever defend all and singular the said premises unto the said Frank Forrest, his

heirs and assigns, against me and my heirs, and against every person whomsoever lawfully claiming or to claim the same, or any part thereof.
