

Mark F. Golightly DEED TO Hilton Babb

KNOW ALL MEN BY THESE PRESENTS, That I, Mark F. Golightly, of the County of Greenville

and

in the State aforesaid

in consideration of the sum of Four hundred Dollars

to me in hand paid at and before the sealing of these presents by

Hilton Babb

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said

Hilton Babb, his heirs and assigns, all that certain piece, parcel or tract of land situate, lying and being in the State of South Carolina, in Greenville County and on the Southeast side of the Rutherford Road and containing Twenty (20) acres, more or less and bounded by lands of Robert Curry Estate, et al.

Also the said Hilton Babb shall have a right of way from the one acre of land to the Twenty acre tract of land, the said right of way for a ^{Wagon} Road to run as follows:

Beginning with W.F. Holtzclaw's line; thence up said Spring branch to another little branch thence up said branch to Robert Curry's line; thence with Curry's line to the Hamby line; thence with the Hamby line to Holtzclaw's line; thence with Holtzclaw's line to W.F. Holtzclaw's line; thence with said W.F. Holtzclaw's line to the beginning.

Being the same tract of land conveyed to me, by Washington Curry by a deed bearing date 12th, day of January 1906, and recorded in the R.M.C. office for Greenville County in Said State in Deed Book W.W.W. at page 28.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in any-wise incident or appertaining.

TO HAVE AND TO HOLD, all and singular the said premises before mentioned unto the said Hilton Babb, his heirs and assigns forever.

AND I do hereby bind myself, my heirs, executors and administrators, to warrant and forever defend all and singular the said premises unto the said Hilton Babb, his

heirs and assigns, against myself and my heirs, and against every person whomsoever lawfully claiming or to claim the same, or any part thereof.
