M. Griffin (the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said

J. M. Griffin, all that certain piece, parcel and lot of land situate, lying and being in the state and county aforesaid and known as Lot no. 17 of plat of Riceland Company said plat being recorded in Plat Book A page 315-
Except a portion of said lot fronting 25 feet on Harris Street and running back 55 feet, cut off from the Northwest corner of the original lot. The deed to this portion hold as aforesaid has not been recorded.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining.
