KNOW ALL MEN BY THESE PRESENTS, That I, Loula M. Briggs, of the County of Greenville, and in the State aforesaid in consideration of the sum of Two hundred and fifty (\$250.00) no/100 DOLLARS, to me in hand paid at and before the sealing of these presents by S.M. Jenkins (the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release, unto the said S.M. Jenkins, all that piece, parcel and lot of land situate, lying and being in the State and County aforesaid, just out-side of the corporate limits of the City of Greenville and having the following metes and bounds, to wit:

Beginning at a stone on the South side of Alexander Street at the corner of a small strip of land belonging to Henry Briggs and running S. 32-15 E. with line of said Briggs lot 32 feet to corner of lot formerly belonging to Mack King; thence S. 56. 45 W. with line of said King lot, 60 feet to other corner of same; thence N. 32-15 W. 32 feet to said Alexnader Street; thence with Street 60 feet to the beginning corner, being a portion of lot No. 9 in the division of the W.P. McBee Farm Tract, conveyed to me by J.L.
