Gower, of the City and County of Greenville in the State aforesaid, in consideration of the sum of Nine Hundred and seventy-five Dollars to us in hand paid at and before the sealing of these presents by Woodville Investment Company, a corporation duly chartered under and by virtue of the laws of said State (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Woodville Investment Company and its successors and assigns, All those certain lots, pieces or parcels of land situate, lying and being in the State of South Carolina, and County of Greenville, in the Second Ward of the City of Greenville, known and designated as lots numbered four (4) and five (5) and the east part of lot numbered three (3) on Joe T.
