And in the event that any vacancy shall hereafter occur in the office of Trustee, whether by death, resignation or otherwise, then the said Greenville Hospital Association, whether incorporated or not, or its successors or assigns, shall have the right to appoint in writing a new trustee or trustees in place of the trustee or trustees so dying, resigning or vacating his office, this power to be exercised from time to time, and as often as may be necessary; and every new trustee so appointed shall be thereupon vested with all the estate, rights and privileges of the trustee or trustees to which he shall immediately or otherwise succeed, as fully and completely in all respects as though such new trustee or trustees were herein named. and the said The Corbett Home does hereby bind itself and its successors to warrant and forever defend all and singular the said premises unto the said H.J. Haynsworth, Trustee and John T. Woodside, Trustee and their successors and assigns, against itself and its successors and against every person whomsoever lawfully claiming or to claim the same or any part thereof.

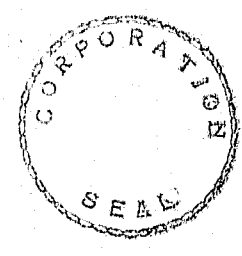
