D. Harris Nicoll, Mrs. Eula Hunt, Mrs. Ora Hunt, and Mrs. Georgia Duncan at and before the sealing
and delivery of these presents (the receipt whereof is hereby acknowledged) have remised,
released and quitclaimed and by these presents do remise, release and quitclaim unto the said
G.W. Nicoll, John L. Nicoll, William W. Nicoll, D. Harris Nicoll, Mrs. Eula Hunt, Mrs. Ora Hunt
and Mrs. Georgia Duncan all my right, title, interest, estate, claim and demand whatsoever, both
at law and in equity (including specifically my dower interest in said land as the widow of the
said David B. Nicoll, deceased) in and to the real estate of the said Washington Nicoll,
deceased, conveyed by the two deeds first hereinabove mentioned.

Together with all and singular the rights, members, hereditaments and appurtenances to the said premises belongins or in any wise incident or appertaining.

To have and to hold all and singular the premises above mentioned unto the said G.W. Nicoll, John L. Nicoll, William W. Nicoll, D. Harris Nicoll, Mrs. Eula Hunt, Mrs. Ora Hunt and Mrs.-Georgia Duncan and their heirs and assigns forever.
