Mitchell:

All that certain piece, parcel and lot of land situate in South Carolina in Greenville

County in the Town of Greer, on the South side of the Franklin Side Track and on the North side

of the Southern Railway Track, and bounded by lands of Mrs. Leila W. Cunningham, Southern

Railway Company Company's Right of way, and others; and being the same lot of land conveyed to

B.F. Reese by W.W. Burgess by deed dated April 29, 1909; and conveyed to Greer Iron Works by

the said B.F. Reese by deed dated January 26, 1912; and known as the Foundry Property.

Also all personal property attached to or in any way connected to the above described premises.

Together with all and singular the Rights, members, hereditements and appurtenances to the said

premises belonging or in anywise incident or appertaining.

TO HAVE AND TO HOLD all and singular the premises before mentioned unto the grantee hereinabove named, and his heirs and assigns forever.
