Gray Master in and for County of Greenville, aforesaid, in consideration of the sum of One hundred and sixty-five Dollars, to me paid by the said J.T. Boling

the receipt whereof is hereby acknowledged, HAVE GRANTED, bargained, sold and released, and by these Presents DO GRANT, bargain, sell and release unto the said J.T. Boling, All that certain lot or parcel of land situate, in the County and State aforesaid, in the South-western part of the City of Greenville, near the incorporate limits, known as lot No. 5, in plat of survey of the lands of the Estate of Aaron Brockman, deceased, made by J.N. Southern, on the 4th, day of September, 1911 and recorded in the R.M.C. Office for Greenville County in Volume "A", page 539, and having the following metes and bounds to wit:

Beginning at an iron stake on 20 foot Street, corner of Lot No. 3, and running; thence N. 77-1/2 W. 95 feet to an iron stake; thence S. 12-1/2 W. 48 feet to an iron stake; thence S. 77-1/2 E. 95 feet to an iron stake on 20 foot Street, corner of Lot No. 7; thence N. 12-1/2 E. 48 feet to an iron stake at the beginning corner, containing four thousand five hundred and sixty square feet more or less.
