demanding judgment in relation to the real estate hereinafter mentioned and described; and the cause being at issue, came on to be heard on the 12th, day of December 1912 and such proceedings were had therein as resulted in a decree of the said Court, whereby it was adjudged and decreed that the said real estate hereinafter mentioned and described, be sold by J.W. Gray Master in and for the County aforesaid, on the terms and for the purposes mentioned in the said decree as by reference thereto on file in said Court will appear; and the Master, after having duly advertised the said real estate for sale by public outcry on the 5th, day of February in the year of our Lord nineteen hundred and twelve did then openly and publicly, according to the custom of auction, sell and dispose of the same unto Nellie Ware

for the sum of One hundred and one Dollars, being at that price the highest bidder therefor. NOW, THEREFORE, Know all men by these Presents, that I, J.W. Gray Master in and for County of Greenville, aforesaid, in consideration of the sum of One hundred and One Dollars, to me paid by the said Nellie Ware

the receipt whereof is hereby acknowledged, HAVE GRANTED, bargained, sold and released, and by these Presents DO GRANT, bargain, sell and release unto the said Nellie Ware, all that certain tract of land situate in the County and State aforesaid, in the South-western part of the City of Greenville near the incorporate limits, and known as lot No. 8 in plat of survey of the lands of Aaron Brockman, deceased, made by J.N. Southern, surveyor, on the 4th, day of September, 1911 and recorded in R.M.C. Office for Greenville County in Volume "A" page 539, and having the following metes and bounds to wit: Beginning at an iron stake on Brockman Street corner of Lot No. 6 and running thence N. 77-1/2 W. 95 feet to an iron stake; thence S. 12-1/2 W. 48 feet to an iron stake; thence S. 77-1/2 E. 95 feet to an iron stake; thence N. 12-1/2 E. 96 feet to an iron stake at the beginning corner. Containing four thousand five hundred and sixty square feet. more or less.
