the receipt whereof is hereby acknowledged, HAVE GRANTED, bargained, sold and released, and by these Presents DO GRANT, bargain, sell and release unto the said H.F. McKinney, all that certain piece, parcel or tract of land situate in the County and State aforesaid, on the Gap Creek Road, and having the following metes and bounds to wit:-  
Beginning at an iron pin on the Jordan Road and running thence N. 25- $\frac{1}{2}$  7.10 to a stone; thence N. 51- $\frac{3}{4}$  W. 49.50 to a stake in the Gap Creek Road, thence along the Gap Creek Road 34.92 to a stake at the intersection of the Gap Creek Road and Jordan Road; thence along the Jordan Road 18.42 chs. to an iron pin at the beginning corner, containing forty acres, more or less.
