TO ALL WHOM THESE PRESENTS SHALL COME:

I, J.W. Gray Master in and for the County aforesaid, SEND GREETING: WHEREAS, Bessie Edens and others

on or about the 21st, April in the year of our Lord nineteen hundred and eleven exhibited their complaint in the Court of Common Pleas, for the County aforesaid, against Nannie Lou Arnold, and others

demanding that the real estate described in the complaint be partitioned among the parties interested therein; and the cause being at issue, came on to be heard on the 22nd, June 1911, and such proceedings were had therein as resulted in a decree of the said Court, whereby it was adjudged and decreed that the said real estate hereinafter mentioned and described, be conveyed by J.W. Gray Master in and for the County aforesaid, to Nannie Lou Arnold for the purposes mentioned in the said decree, as by reference thereto on file in said Court, will appear; (See Judgment Roll No. -).

NOW, THEREFORE, Know all men by these Presents, that I, J.W. Gray Master in and for the County of Greenville aforesaid, by virtue of the aforesaid decree, HAVE GRANTED, conveyed and released, and by these presents, DO GRANT, convey and release unto the said

Nannie Lou Arnold, all those two certain lots or parcels of land situate in Greenville Township, County and State aforesaid about three and one half miles West of Greenville Court House, near the Southern Railway, known as lots A-1 and A-2. in plat of survey of lands of the Estate of Ansel Arnold, deceased, made pursuant to order of the Court, by F.G. Rogers, surveyor August 2, 1911, recorded in office of R.M.C. for Greenville County in Plat Book A. pages 512 and 513., and having the following metes and bounds, to wit: Beginning at a stake in road on line of lot "C" and running; thence S. 13-1/4 E. 530- feet to stake corner of lots A-2 and B-1; thence N. 81 W. 2.90 feet to a stake; thence N. 13-1/4 W. 530 feet to stake in road; thence along said road as the line S. 83 E. 289 feet to the beginning corner, containing three and one-half acres, more or less, and designated on said plat as lot "A-1". Also beginning at a stake on right of way of the G.S. & A. Railway and running; thence S.W. with said right-of-way 480 feet to stake, corner of lot "D"; thence N. 13-1/4 W. 505 feet to stake corner of of lot "A-1"; thence S. 81 W. 200 feet to the beginning corner containing seven tenths (7/10) of an acre, more or less and designated on said plat as lot "A-2".

TOGETHER with all and singular the Rights, Members, Hereditaments and Appurtenances to the said Premises belonging, or in anywise incident or appertaining; and all the estate, right, title, claim and interest whatsoever, of the parties to the cause aforesaid, and of each of them in and to the same; and all other persons rightfully claiming from, under, or any of them.

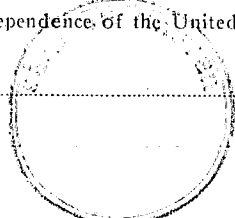
TO HAVE AND TO HOLD, all and singular, the premises before mentioned, unto the said Nannie Lou Arnold, her heirs and assigns forever.
