Master in and for the County of Greenville aforesaid, by virtue of the aforesaid decree, HAVE GRANTED, conveyed and released, and by these presents, DO GRANT, convey and release unto the said

J.J. Lister, All that tract of land situate in County and State aforesaid, known as lot No. 2, on plat of survey of lands of D.C. Lister, deceased, made by J.H. Atkins, bearing date 30th, day of August, 1911, consisting of two separate tracts, one containing thirty-nine and 82/100 acres and the other containing seven and 19/100 acres, aggregating forty-seven and 1/100 acres. The first of these tracts has the following metes and bounds, to wit: Beginning at a stone NM on road corner of Lot No. 3 and running; thence S. 52-1/2 E. 2.91 to a stone NM on road; thence along said road N. 89 E. 4.00 to stone NM in road; thence S. 44-1/4 E. 9.00 to a stone OM; thence N. 60-3/4 E. 14.00 to a stone OM; thence N. 38 E. 6.33 to a stone NM on road; thence N. 44-1/4 W. 18.47 to a stone NM; thence S. 83-3/4 W. 11.50 to a stone OM; thence S. 33-3/4 E. 9.67 to a stone NM; thence S. 67 W. 7.75 to a stone NM; thence S. 29 W. 5.49 to a stone NM, corner of lot No. 3 at the beginning corner. The second of these tracts has the following metes and bounds to wit: Beginning at a stone on the corner of lot No. 3, and running; thence N. 41 W. 3.03 to a stone NM; thence N. 18-1/2 E. 5.28 to a stone NM on road; thence S. 77-1/4 W. 3.27 to a stone NM; thence S. 15 W. 3.61 to a stone NM; thence S. 73-1/4 W. 2.05 to stone NM; thence S. 16-1/2 W. 8.97 to a stone NM; thence S. 64-3/4 E. 5.64 to stone NM; thence N. 19-3/4 E. 5.43 to a stone NM; thence N. 31 E. 3.95 to a stone at the beginning corner.

TO HAVE AND TO HOLD, all and singular, the premises before mentioned, unto the said

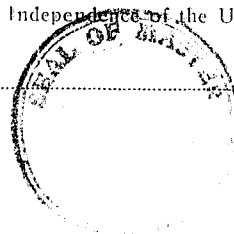
J.J. Lister, his heirs and assigns forever.
