on or about the first day of January in the year of our Lord nineteen hundred and twelve exhibited his complaint in the Court of Common Pleas, for the County aforesaid, against Samuel A. Hall et al.

demanding that the real estate described in the complaint be partitioned among the parties interested therein; and the cause being at issue, came on to be heard on the 7th day of October 1913, and such proceedings were had therein as resulted in a decree of the said Court, whereby it was adjudged and decreed that the said real estate hereinafter mentioned and described, be conveyed by J.W. Gray, Master in and for the County aforesaid, to Garfield Hall for the purposes mentioned in the said decree, as by reference thereto on file in said Court, will appear; (See Judgment Roll No. ...)

NOW, THEREFORE, Know all men by these Presents, that I, J.W. Gray, Master in and for the County of Greenville aforesaid, by virtue of the aforesaid decree, HAVE GRANTED, conveyed and released, and by these presents, DO GRANT, convey and release unto the said

Garfield Hall, All that certain parcel or lot of land just outside the corporate limits of the City of Greenville, County and State aforesaid, known as lot No. 6 in the plat of survey of land of James E. Hall, deceased, recorded in R.M.C. office of Greenville County, Plat Book C. page 90, having the following metes and bounds, to-wit: Beginning at a stake on north side of neighborhood road, corner of lot 4; thence N. 30° 15' E. 109 ft. to a stake on said road, corner of lot 8; thence N. 1° 53' W. 324 feet to a stake, corner of lots 5, 7, 8; thence S. 70° 45' W. 122.5 feet to a stake, corner of lots 3, 4, 5; thence S. 3° 49' E. 303.5 feet to the beginning corner.

TOGETHER with all and singular the Rights, Members, Hereditaments and Appurtenances to the said Premises belonging, or in anywise incident or appertaining; and all the estate, right, title, claim and interest whatsoever, of the parties to the cause aforesaid, and of each of them in and to the same; and all other persons rightfully claiming from, under, or any of them.

TO HAVE AND TO HOLD, all and singular, the premises before mentioned, unto the said Garfield Hall, his heirs and assigns forever.
