KNOW ALL MEN BY THESE PRESENTS, That I, W.W. Green of the County of Greenville

in the State aforesaid

in consideration of the sum of

Five Dollars and love and affection which I bear to my wife, Alice Green

to me in hand paid

at and before the sealing of these presents by Alice Green

(the receipt whereof

is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release, unto the said

Alice Green, her heirs and assigns, All that certain piece, parcel or tract of land situate, lying and being in the County and State aforesaid, on Farr's Bridge Road, about two and one-half miles from the City of Greenville, and described as follows, to-wit: Beginning at a stake 3XNM on the North side of said Farr's Bridge Road, and South west corner of Thos. Springfield's line; running thence with said Springfields line North 8-1/2 E. 210 feet to stake 3XNM; thence N. 80-1/2 W. 160 feet to stake 3XNM; thence South 81-1/2 W. 210 feet to stake 3XNM on the said Farr's Bridge Road; thence South 80-1/2 E. along the North side of said Road 160 feet to the beginning corner, containing 77/100 of an acre, more or less, bounded on the North and West by lands of J.A. Finlay; on the East by said Thos. Springfield, and South by said Farr's Bridge Road, and being the same tract of land conveyed to me by Mamie E. Springfield by deed dated March 21st, 1912 and recorded in R.M.C. Office for Greenville County in Volume --

Also, all that other piece, parcel or tract of land situate, lying and being on the East side of Woodside Avenue, in the County of of Greenville and State of South Carolina, and having the following metes and bounds, to-wit: Beginning at a point on the East side of Woodside Avenue, common to lots Nos. 1 and 2; thence with Woodside Avenue, N. 13-3/4 E. 50 feet to pin; thence N. 82-3/4 E. 116.3 feet to pin; thence S. 7-1/4 E. 50 feet to pin; thence S. 82-3/4 W. 133.6 to pin at beginning point;

Also all that other piece, parcel or tract of land situate, lying and being in the County and State aforesaid, adjoining the above lot, and having the following metes and bounds, to-wit: Beginning at point on the North side of the Bramlett Road common to lots Nos. 1 and 3; thence N. 7-1/4 W. 125 feet to pin; thence N. 82-3/4 E. 50 feet to pin; thence S. 7-1/4 E. 125 feet to pin on Bramlett Road; thence S. 82-3/4 E. 50 feet with Bramlett Road to the beginning point;

Also, all that other piece, parcel or lot of land situate, lying and being just outside of the incorporate limits of the City of Greenville, County and State aforesaid, and having the following metes and bounds, to-wit: Beginning at a point on the Bramlett Road and Woodside Avenue, running with Woodside Ave. N. 13-3/4 E. 84 feet and 8 inc. to stake; thence N. 82-3/4 E. 133 feet and 6 ins. to stake; thence S. 7-1/4 W. 75 feet to stake on Bramlett Road; thence with said Road S. 82-3/4 W. 165 feet to the beginning corner;

Also all that other piece, parcel or lot of land situate, lying and being in the County and State aforesaid, on the New Cut Road, known as the Bramlett Road on Morgan Hill Annex, and known as Lot No. 56 on plat made by J.E. Serrine, said plat being recorded in R.M.C. Office for Greenville County in Plat Book "A" pages 68 and 69 and fronting on the Bramlett Road 60 feet and running back in parallel lines 200 feet;

The last four lots hereinabove described are the same and all the lots conveyed to me by J.D. Sheppard by deed dated December 21st, 1911 and recorded in R.M.C. Office for Greenville County in Volume 16, page 30, EXCEPT one lot known as Lot No. 13.
