KNOW ALL MEN BY THESE PRESENTS, That Agar L. Ridgeway of Greenville,  
County

in the State aforesaid  
Four thousand and five hundred (4500) in consideration of the sum of

to me in hand paid  
at and before the sealing of these presents by Jerry F. M<sup>o</sup>Kenzie of the town of Honeas  
Paths, Anderson County

(the receipt whereof  
is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release, unto the said

Jerry F. M<sup>o</sup>Kenzie, all of a certain tract of land containing fifty  
four and  $\frac{5}{100}$  ( $54\frac{5}{100}$ ) acres more or less, situate in  
both Greenville and Laurens counties in the state aforesaid,  
being about ten  $\frac{1}{2}$  ( $10\frac{1}{2}$ ) acres in Laurens county, Beginning  
at a stone 3x0 on the northeast side of a branch, thence down  
the meanderings of said branch about 35.0 to an iron 3x0. Bound-  
ed by C. W. Simpson and Mrs. McNeil. Thence S. 16 $\frac{1}{2}$  E. 29.28  
iron 3x0. Thence S. 24 E. 7.57 iron 2x0. in southeast edge of road.
