

The Norwood National Bank DEED TO Mrs. Mary Lou Bates

KNOW ALL MEN BY THESE PRESENTS, That The Norwood National Bank of Greenville

a corporation chartered under the laws of the United States and having its principal place of business at Greenville in the State of South Carolina for and in consideration of the sum of Eight hundred DOLLARS, to it in hand duly paid at and before the sealing and delivery of these presents by the grantee... hereinafter named, (the receipt whereof is hereby acknowledged) has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto

Mrs. Mary Lou Bates, All that piece, parcel or lot of land lying, being and situate in the State and County aforesaid, known as Lot 8 in sub-division of Buist Property, by survey of W.D. Neves June 1st, 1911.

Beginning at a stake Four hundred and fifty feet from corner of Towns Street and Mountain View Avenue; thence with Mountain View Avenue in a Westerly direction One hundred feet to a stake, joint corners of lots No's. 7 and 8; thence with dividing line of lots 7 and 8 in a Southerly direction, One hundred and seventy feet six inches to a stake at corner of Lots 7 and 8 and an Alley; thence with said Alley in an Easterly direction, One hundred feet to a stake at corner of lots No's. 8 and 9; thence with dividing line of lots No's. 8 and 9 in a Northerly direction One hundred and seventy feet six inches to the beginning corner, on Mountain View Avenue.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining.

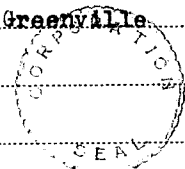
TO HAVE AND TO HOLD, all and singular, the premises before mentioned unto the grantee...hereinabove named, and his heirs and assigns forever.

And the said granting corporation does hereby bind itself and its successors to warrant and forever defend all and singular the said premises unto the grantee... hereinabove named, and his heirs and assigns, against itself and its successors, and against every person whomsoever lawfully claiming or to claim the same or any part thereof.

In witness whereof the said granting corporation has caused its corporate seal to be hereunto affixed and these presents to be subscribed by its duly authorized officers, J.W. Norwood, its President and S.A. Moore, its Cashier on this the twenty-third day of March, in the year of our Lord one thousand nine hundred and twelve, and in the one hundred and thirty-six year of the Sovereignty and Independence of the United States of America.
