KNOW ALL MEN BY THESE PRESENTS, That The Norwood National Bank of Greenville

a corporation chartered under the laws of the ~~State~~ United States and having its principal place of business at Greenville in the State of South Carolina for and in consideration of the sum of Three thousand & no/100 DOLLARS, to it in hand duly paid at and before the sealing and delivery of these presents by the grantee... hereinafter named, (the receipt whereof is hereby acknowledged) has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto...

Belle B. Hunt, All that certain piece, parcel or lot of land, situate, lying and being in the County of Greenville near the corporate limits of the City of Greenville, same being a portion of the Buist Property and having the following metes and bounds to wit:- Beginning at a stake on Mountain View Ave; joint corners of lots Nos. 4 and 5 and running thence with said Mountain View Ave; two hundred feet to a stake, joint corners of lots Nos. 6 and 7, thence with said Joint lines in a Southernly direction, three hundred and seventy nine feet to a stake corner of Buist Ave; joint corners of lots Nos. 15 and 16, thence along with Buist Ave; in a Westernly direction, two hundred feet to a stake, joint corners of lots Nos. 13 and 14, thence with said joint lines in a Northernly direction, three hundred and seventy nine feet to a stake at the beginning corner, same being known as lots Nos. 5, 6, 14 and 15, according to a plat made by W.D. Neves, June, 1911.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining.

TO HAVE AND TO HOLD, all and singular, the premises before mentioned unto the grantee...hereinabove named, and... her heirs and assigns forever.

And the said granting corporation does hereby bind itself and its successors to warrant and forever defend all and singular the said premises unto the grantee... hereinabove named, and her heirs and assigns, against itself and its successors, and against every person who shall lawfully claim or to claim the same or any part thereof.

In witness whereof the said granting corporation has caused its corporate seal to be hereunto affixed and these presents to be subscribed by its duly authorized officers, J.W. Norwood, its President and S.A. Moore, its Cashier on this the 5th day of October, in the year of our Lord one thousand nine hundred and twelve, and in the one hundred and ... year of the Sovereignty and Independence of the United States of America.
