KNOW ALL MEN BY THESE PRESENTS, That The Norwood National Bank of Greenville

a corporation chartered under the laws of the United States and having its principal place of business at Greenville in the State of South Carolina for and in consideration of the sum of Three thousand DOLLARS, to it in hand duly paid at and before the sealing and delivery of these presents by the grantee...

C.C. Jones, his heirs and assigns, all those certain lots or parcels of land situate near the City of Greenville, in the County and State aforesaid, known as part of the Buist property and described as follows: Beginning at a stake on Mountain View Avenue, joint corners of lots 7 and 8, and runs thence in a Southernly direction along the line of Lots 7 and 16 three hundred and seventy nine feet to a stake on Buist Avenue at corner of lots 16 and 17, thence along Buist Avenue one hundred and eighty three feet and eight inches to Robinson Street, thence in a Northernly direction along said Street three hundred and seventy nine feet to a stake on said Mountain View Avenue, thence in a Westernly direction along said Avenue one hundred and eighty three feet and eight inches to the beginning corner, being known as lots 8, 9, 17 and 18 and including that portion of the alley shown on plat, which lies between the lines herein given, said plat being made by W.D. Neves June the 1st, 1911, and shows the lots above described. Same being parts of the land conveyed to said Bank by Eliza F. Buist by deed dated the 25th, day of May 1911 and recorded in Volume 13 at page 20.

TO HAVE AND TO HOLD, all and singular, the premises before mentioned unto the grantee...hereinabove named, and his heirs and assigns forever.

And the said granting corporation does hereby bind itself and its successors to warrant and forever defend all and singular the said premises unto the grantee... hereinabove named, and his heirs and assigns, against itself and its successors,...

Norwood, President and S.A. Moore, Cashier on this the 10th, day of October, in the year of our Lord one thousand nine hundred and twelve, and in the one hundred and 37th, year of the Sovereignty and Independence of the United States of America.
