a corporation chartered under the laws of the State of South Carolina and having its principal place of business at Greenville in the State of South Carolina for and in consideration of the sum of Forty-one hundred and twenty-five DOLLARS, to it in hand duly paid at and before the sealing and delivery of these presents by the grantee... hereinafter named, (the receipt whereof is hereby acknowledged) has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto

Mabel McB. Charles, her heirs and assigns, All that lot of land situate on the South side of Rhett Street, in the City and County of Greenville, South Carolina, being known as lot No. 59 as shown on plat recorded in plat book E., page 146 and described as follows: Beginning on the south side of Rhett Street at the corner of lot No. 58 and running thence along said Street N. 71-54 E. 25 feet to the corner of lot No. 60; thence along line of that lot S. 10-42 E. 95 feet; thence S. 71-56 W. 26.1 feet; thence N. 10-38 W. 95 feet to the beginning corner.
