DEED TO J. B. Heatherly

KNOW ALL MEN BY THESE PRESENTS, That

Judson Mills

a corporation chartered under the laws of the State of South Carolina and having its principal place of business at Greenville in the State of South Carolina, for and in consideration of the sum of Ten (\$10.00) dollars and other considerations DOLLARS, to it in hand duly paid at and before the sealing and delivery of these presents by the grantee... hereinabove named, (the receipt whereof is hereby acknowledged) has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto...

J. B. Heatherly his heirs and assigns:
All that piece parcel and lot of land situate in the State of South Carolina and County of Greenville, as shown on plat of the Judson Mills being designated on said plat as L of No. 8. Said lot has the following, miles and bounds, to wit:
Beginning at head end twenty-foot road; thence southwest along said twenty-foot road 159 feet to corner of lot no 7; thence northeast 700' 0" to an iron pin at the track of the Southern Public Utilities Co.; thence northwest 330' 0" along track of the Southern Public Utilities Co. to an iron pin; thence southeast 360' 0" to an iron pin on the twenty-foot road; thence southwest 400' along the twenty-foot road to the original starting point. Said lot to contain 4.6 acres, more or less.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining.

TO HAVE AND TO HOLD, all and singular, the premises before mentioned unto the grantee... hereinabove named, and his heirs and assigns forever.

And the said granting corporation does hereby bind itself and its successors to warrant and forever defend all and singular the said premises unto the grantee... hereinabove named, and his heirs and assigns, against itself and its successors, and against every person whomsoever lawfully claiming or to claim the same or any part thereof.

Greer, President and Treasurer, B. S. Mills, Secy, on this the 17th day of January, in the year of our Lord one thousand nine hundred and twenty, and in the one hundred and forty fourth year of the Sovereignty and Independence of the United States of America.
