KNOW ALL MEN BY THESE PRESENTS, That Colonia Company

a corporation chartered under the laws of the State of South Carolina and having its principal place of business at Greenville in the State of South Carolina for and in consideration of the sum of Two thousand DOLLARS, to it in hand duly paid at and before the sealing and delivery of these presents by the grantee... hereinafter named, (the receipt whereof is hereby acknowledged) has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto...

B.S. Allen, All that piece, parcel or lot of land in the State and County aforesaid, about three miles northwest of the City of Greenville and being a part of subdivision known as Sans Souci having the following metes and bounds, to-wit:

Beginning at an iron pin on east side of Clarendon Avenue also the corner of A.C. Walkers lot; thence S. 43-50 E. 350 feet to an iron pin; thence S. 46-10 W. 260 feet to an iron pin; thence S. 88-55 W. 80 feet to an iron pin northeast side of Circle Road; thence with Circle Road, and with curve of same approximately as follows, N. 13-30 E. 70 feet, N. 19-21 W. 111.3, thence 60-14 W. 162 feet to Clarendon Avenue; thence with Clarendon Avenue N. 46 E. 260.75 feet to the beginning corner.

Subject to the following conditions and stipulations.

First: that said property shall be used for residential purposes for white people only (this not to apply to servants).

Second: That no residence shall be erected on this lot or subdivision thereof to cost less than \$6000. and there shall be built a residence thereon within twelve months from date.

Third: that purchaser hereof his heirs, administrators, executors, successors or assigns, shall be amenable to sanitary rules and regulations passed by a majority of the holders of property purchased from Colonia Company.

These stipulations and conditions are material and have effected the purchase price hereof and are therefore conditions subsequent.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining.

TO HAVE AND TO HOLD, all and singular, the premises before mentioned unto the grantee...hereinabove named, and his heirs and assigns forever.

And the said granting corporation does hereby bind itself and its successors to warrant and forever defend all and singular the said premises unto the grantee... hereinabove named, and his heirs and assigns, against itself and its successors, and against every person whomsoever lawfully claiming or to claim the same or any part thereof.

In witness whereof the said granting corporation has caused its corporate seal to be hereunto affixed and these presents to be subscribed by its duly authorized officers, to-wit: W.J. Thackston, President and Treasurer on this the 22nd, day of April, in the year of our Lord one thousand nine hundred and twenty, and in the one hundred and 44th year of the Sovereignty and Independence of the United States of America.
