Knight, Fountainville, S.C., in the State aforesaid in consideration of the sum of Three Hundred DOLLARS, in hand paid and before the sealing of these presents by Grace L. Knight, Graniteville, S.C. (the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release, unto the said

Grace L. Knight, a certain parcel or tract of land, lying, being and situate in the town of Fountainville, S.C., lying on the North side of Gulliver St. and beginning on a rock in the road leading from John A. Marlars residence to Newport Garrett, and the said rock, being the N.W. corner of the Colored Baptist Church lot, running thence along the said road N.W. to a poplar tree present corner of my land on that side, thence up the branch to Gloria B. Dupkett lot, rock corner; thence following her line to Gulliver St. rock corner, thence following the rock to G.L. Knight, Graniteville, S.C. (the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release, unto the said

Grace L. Knight, a certain tract of land lying, being and situate in the County of Greenville, and adjoining to the town of Fountainville, S.C., beginning on a rock 34 in front of residence of John Marlars, and running S 75° E 10.75 to rock 24; thence S 22° W 45.50 to rock 24; thence running toward the road from which you started and following along an old road keeping the side of wood hill you reach center of road which leads to Herbert Shoals to rock 24; thence with said road to the beginning rock 24; bounded by land of John A. Marlars, Sarah Stewart, and P.J. Knight and containing five (5) acres, all in wood. Also the following, beginning on the rock corner in front of the residence of J.P.
