DEED TO J.M. Steele

KNOW ALL MEN BY THESE PRESENTS, That I, E.K. Young

in the State aforesaid in consideration of the sum of Five thousand DOLLARS, to me in hand paid at and before the sealing of these presents by J.M. Steele (the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release, unto the said

J.M. Steele, his heirs and assigns, all that lot of land situate at the southwest corner of Frank and Pinckney Streets, in the City and County of Greenville, South Carolina, beginning at an iron pin on the corner of said Streets, and runs thence along Frank Street fifty-six feet to an iron pin at the corner of the Mitchell lot; thence along that line and parallel with Pinckney Street one hundred and thirty-three feet to an iron pin; thence on a line parallel with Frank Street and with the line of the Mitchell lot, forty-six feet to an iron pin; thence on a line parallel with Pinckney Street, thirty-two feet to an iron pin; thence in an easterly course twelve feet to an iron pin on an alley; thence along said alley ninety-six feet to an iron pin on Pinckney Street; thence along said Street one hundred and seventy-five feet to the beginning corner; the above being a part of the land conveyed to me by J.N. Alverson by deed dated the 15th day of October, 1912 and recorded in Volume 21, page 281.

The said J.M. Steele by accepting this deed assumes the payment of a note for Twenty-five hundred Dollars by me to Oscar Hodges, Atty. secured by a mortgage upon the above property.

TOGETHER WITH, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in any-wise incident or appertaining.

TO HAVE AND TO HOLD, all and singular, the said premises before mentioned unto the said

J.M. Steele, his heirs and assigns, forever.

AND I do hereby bind myself, my heirs, executors and administrators, to warrant and forever defend, all and singular, the said premises unto the said J.M. Steele, his

heirs and assigns, against myself and my heirs, and against every person whomsoever lawfully claiming or to claim the same, or any part thereof.
