(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release, unto the said

H.G. Copeland, All that piece or lot of land situated, lying and being in said State and County Chick Springs Township in the Town of Taylors on the National Highway, beginning at a stake on the said National Highway and on a street running across the Southern Railway and running thence along the said Street 320 feet to a stake on another street and thence along this latter street 225 feet to a stake; thence 300 feet to a stake on the said National Highway; thence along the said National Highway 100 feet to the beginning corner, known as lots numbers 30, 31, 50, 51 and 52 on a plat of W.A. Adams, dated April 22nd, 1913 and recorded in Plat Book C, page 74.
