KNOW ALL MEN BY THESE PRESENTS, That I, Amanda Scott
in consideration of the sum of Five dollars and in the further consideration of a division of my property on Staunton Bridge Road
to me in hand paid at and before the sealing of these presents by Anna Wilson of the State and County aforesaid

Anna Wilson, All that certain piece, parcel or tract of land situate, lying and being in the
State and County aforesaid, on the East side of Staunton Bridge Road and is about 3-1/2 miles
from Greenville, S.C. and is known in said division of my land as lot No. 2 on plat made by
W.D. Neves Esq. Feb. 1913, and has the following metes and bounds to-wit: Beginning at an iron
pin 3X NM on the East side of Staunton Bridge Road, also the 3X of Lot No. 1 and runs thence
with line of lot No. 1 S. 69-30 E. 478 feet to I.P. on James Scotts line; thence with said line
N. 2 E. 95 ft. to I.P. 3X, also the 3X of lot No. 3, thence with line of lot No. 3 N. 71-30 W.
482 ft. to I.P. on road, thence with road S. 3 E. 80 ft. to the beginning 3X and contains
