is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release, unto the said

Mariah Thompson, All that piece, parcel and tract of land lying, situate and being in the State and County aforesaid, and Paris Mountain Township. Known as a part of No four tract in Gabriel-Thompson, Estate and in the subdivision as No. 3 tract and a part of the Rutledge Place, adjoining land of John B. Hester and tract No. two and four, bound as follows. Beginning on a poplar on the branch, thence S. 41 W. 18.14 to a dogwood X3NM; thence S. 40-3/4 E. 3.60 to a stone NM; thence N. 38-1/2 E. 17.80 to a stone NM on the branch, thence up the branch 2.90 to the beginning poplar and contains five and a half (5-1/2) acres, be the same more or less, and we hereby reserve a right of way through the above described place where the old road now is.
