KNOW ALL MEN BY THESE PRESENTS, That I, Alfred G. Taylor, by virtue of authority conferred upon me as executor of Alfred Taylor, deceased, by will on file in the Probate Court for Greenville County in the State aforesaid

in consideration of the sum of Ninety-five DOLLARS, to me in hand paid at and before the sealing of these presents by

Z.V. Wood

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release, unto the said

Z.V. Wood, all that piece or lot of land situated, lying and being in said State and County Chick Springs Township, in the Town of Taylors on the National Highway, known as lots numbers thirty-four and forty-seven of the Alfred Taylors Estate, as shown by a plat of W.A. Adams, dated April 22nd, 1913, running fifty feet along the said National Highway and running back three hundred feet to another Street. The above plat is recorded in Plat Book C. page 74.

TOGETHER WITH, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in any-wise incident or appertaining.

TO HAVE AND TO HOLD, all and singular, the said premises before mentioned unto the said Z.V. Wood, his heirs and assigns, forever.

AND I do hereby bind Alfred Taylors heirs, executors and administrators, to warrant and forever defend, all and singular, the said premises unto the said Z.V. Wood, his

heirs and assigns, against him and his heirs, and against every person whomsoever lawfully claiming or to claim the same, or any part thereof.
