KNOW ALL MEN BY THESE PRESENTS, That We, Ella V. Babb and Isabella Babb of the City and County of Greenville,

in the State aforesaid in consideration of the sum of One dollar (\$1.00) DOLLARS, to us in hand paid at and before the sealing of these presents by the City of Greenville, a municipal corporation duly chartered under the laws of said State, (the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release, unto the said

City of Greenville and its successors and assigns forever, all that certain piece, parcel or strip of land situate, lying and being in the State of South Carolina and County of Greenville, in the Second Ward of the City of Greenville, on the west side of Brown Street, between Coffee and North Streets, having a length along said Brown Street of sixty-three (63) feet, more or less and being about four and one-half (4-1/2) feet wide throughout its entire length; bounded on the east by Brown Street, on the North by lot of W.E. Wright, on the south by lot of William C. Gibson and on the west by other land belonging to us, the said Ella V. Babb and Isabella Babb; the intention of this deed being that the said Brown Street shall be forty (40) feet in total width or thirty (30) feet between the curb stones; all being substantially as shown on a map of Brown Street made by the City Engineer of said City, bearing date February 28, 1913.
