in consideration of the sum of One hundred and no/100 DOLLARS,

to me in hand paid at and before the sealing of these presents by

M. E. Henderson (the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release, unto the said

M. E. Henderson all that piece, parcel or lot of land situate, lying and being in the State and County aforesaid, near the Town of Greer and having the following metes and bounds: Beginning at W. E. Long's corner and runs thence S. 58-1/2 E. 100 feet to an iron pin; thence N. 32-1/2 E. 218 feet to an iron pin; thence S. 58-1/2 W. 100 feet to an iron pin; thence S. 32-1/4 W. 218 feet to the beginning corner, containing one-half acre, more or less.

TOGETHER WITH, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in any-wise incident or appertaining.

TO HAVE AND TO HOLD, all and singular, the said premises before mentioned unto the said
