 KNOW ALL MEN BY THESE PRESENTS, That I, D.E. Lineberger of Simpsonville,
 Greenville County and in the State aforesaid

in consideration of the sum of Three hundred DOLLARS,
 to me in hand paid at and before the sealing of these presents by
 W.E. Crisp of Simpsonville, S.C. (the receipt whereof
 is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release, unto the said

W.E. Crisp, All that certain piece, parcel or lot of land situate, lying and being in the
 Town of Simpsonville, S.C. fronting on Church St. Beginning on an iron pin on Church St.
 Hickson Smiths corner and running thence along Church St. North sixty-five (65) feet to an
 iron pin 3x, thence West two hundred (200) feet to an iron pin 3X, thence south sixty five
 (65) feet to an iron pin Hickson Smiths corner 3x, thence along Smiths line East two hundred
 (200) feet to iron pin, the beginning corner, and containing thirteen thousand Sq. feet,
 more or less.

TOGETHER WITH, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in any-
 wise incident or appertaining.
 TO HAVE AND TO HOLD, all and singular, the said premises before mentioned unto the said
 W.E. Crisp, and his heirs and assigns, forever.

AND I do hereby bind myself and my heirs, executors and administrators, to warrant and
 forever defend, all and singular, the said premises unto the said W.E. Crisp, and his
 heirs and assigns, against me and my heirs, and against
 every person whomsoever lawfully claiming or to claim the same, or any part thereof.
