KNOW ALL MEN BY THESE PRESENTS, That We, J.M. Abercrombie, Ida Franklin, Mary Montgomery, Ellen Gray, J.W. Abercrombie, Maggie Morton, Roscoe Means & Polly Kilgore in the State aforesaid

in consideration of the sum of Five hundred DOLLARS, to Tecora Evins in hand paid at and before the sealing of these presents by

Tecora Evins (the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release, unto the said Tecora Evins, all that piece, parcel and tract of land situate, lying and being in Butler Township in the County and State aforesaid, adjoining lands of J.A. Forrester, E.P. Taylor & others, containing twenty one acres more or less and described by metes and bounds as follows: Beginning on a stone ( E.P. Taylors line) thence N. 42 E. 23.25 chains to a stone on branch; thence N. 48 W. 10.50 chains to a stone, thence S. 37-2 W. 24.85 chains to a stone (Roscoe Means-line), thence S. 56 E. 8.00 chains to the beginning corner.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in any-wise incident or appertaining.

TO HAVE AND TO HOLD, all and singular, the said premises before mentioned unto the said Tecora Evins, her heirs and assigns, forever.

AND we do hereby bind ourselves & our heirs, executors and administrators, to warrant and forever defend, all and singular, the said premises unto the said Tecora Evins, and her

heirs and assigns, against ourselves and our heirs, and against every person whomsoever lawfully claiming or to claim the same, or any part thereof.
