DEED TO Elwell Rosemond

STATE OF SOUTH CAROLINA,

COUNTY OF Greenville

KNOW ALL MEN BY THESE PRESENTS, That We, D.G., - J.H., - J.C., - Ella and Lucy Rosemond and Essie Wells and Nancy Birten, heirs of the late Millie Rosemond in the State aforesaid in consideration of the sum of One Dollar and other considerations DOLLARS, to us in hand paid at and before the sealing of these presents by Elwell Rosemond

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release, unto the said Elwell Rosemond, All that piece, parcel of land lying and being in the State and County aforesaid, on the Easley Bridge Road, about three miles from the City of Greenville, and being a part of the lands of the late Millie Rosemond, and having the following metes and bounds, to wit:

Beginning at a stake on a 20 ft. private road cor. of lots No. 1 and No. 7, and running thence with said road N. 43 W. 3.80 chains to a stake on the Earle line; thence with said Earle line S. 71 W. 8.00 chains to a stone Looper's cor. thence with loopers line S. 31-1/2 E. 7.00 chains to the cor. of lot No. 7; thence with line of said lot N. 47 E. 8.30 chains to the beginning cor. containing three and one-half (3-1/2) acres, more or less, and shown as lot No. 8 on plat made by F.G. Rogers, Feb. 1912.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in any-wise incident or appertaining.

TO HAVE AND TO HOLD, all and singular, the said premises before mentioned unto the said Elwell Rosemond, his heirs and assigns, forever.

AND we do hereby bind ourselves, our heirs, executors and administrators, to warrant and forever defend, all and singular, the said premises unto the said Elwell Rosemond, his

heirs and assigns, against us and our heirs, and against every person whomsoever lawfully claiming or to claim the same, or any part thereof.
