DEED TO

R. Psyche Webster

STATE OF SOUTH CAROLINA,

KNOW ALL MEN BY THESE PRESENTS, That I, Annie C. Webster of Greenville County

in consideration of the sum of Five dollars (and natural love and affection for my daughter, the grantee) in the State aforesaid to me in hand paid at and before the sealing of these presents by R. Psyche Webster

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release, unto the said

R. Psyche Webster; All that piece, parcel or lot of land in the County and State aforesaid, containing one and one-fourth (1 1/4) acres, more or less, according to a plat by W.D. Neves, dated July 6, 1912, and being a part of my present home place. The lot herein conveyed is known as No. 2 on said plat and has the following metes and bounds, courses and distances: Beginning at a pin at ditch on corner of lot No. 1, and running thence along lot No. 1, S. 45° 20' W. two hundred and eighty-seven (287) feet to an iron pin; thence N. 42 W. two hundred (200) feet to iron pin, corner of lot No. 3; thence along lot No. 3, N. 45° 20' E. two hundred and seventy four (274) feet to iron pin on ditch; thence S. 46° 30' E. two hundred (200) feet to the beginning point.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in any-wise incident or appertaining.

TO HAVE AND TO HOLD, all and singular, the said premises before mentioned unto the said R. Psyche Webster, and her heirs and assigns, forever.

AND I do hereby bind myself & my heirs, executors and administrators, to warrant and forever defend, all and singular, the said premises unto the said R. Psyche Webster and her

heirs and assigns, against me and my heirs, and against every person whomsoever lawfully claiming or to claim the same, or any part thereof.
