KNOW ALL MEN BY THESE PRESENTS, That we, W. N. Miller and E. E. Stone

in the State aforesaid in consideration of the sum of Forty five & no/100 DOLLARS, to us in hand paid at and before the sealing of these presents by Sarah Redmond

Sarah Redmond (the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release, unto the said

Sarah Redmond - All that certain piece, parcel or lot of land situate, lying and being in the State and County aforesaid near the city limits of the City of Greenville, known as Ricketts section and being lot no. 32. of a plat made for W. N. Miller and E. E. Stone by Will W. Neves, March 12th 1914 said plat recorded in R. M. C. Office in plat 2300 page. Said lot having a frontage on West Ave. of 30 feet and a depth of 75 feet.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in any-wise incident or appertaining.

TO HAVE AND TO HOLD, all and singular the said premises before mentioned unto the said Sarah Redmond, her heirs and assigns, forever.

AND we do hereby bind ourselves, our heirs, executors and administrators, to warrant and forever defend, all and singular, the said premises unto the said Sarah Redmond, her heirs and assigns, against us and our heirs, and against every person whomsoever lawfully claiming or to claim the same, or any part thereof.
