 and County of *Greenville*, in the State aforesaid  
 in consideration of the sum of *One Thousand Dollars (\$1000.00)*  
 to me in hand paid at and before the sealing of these presents by  
*A. L. Mills* (the receipt whereof  
 is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release, unto the said  
*A. L. Mills*, his heirs and assigns forever:  
 All that certain strip of land situate on the East side  
 of Main Street in Ward Four of the City of Greenville, County  
 and State aforesaid, and having the following lines and bounds:  
 Beginning at the corner of *A. L. Mills'* property on Main  
 Street, and running thence with Main Street, S. 20° 30' W.  
 twelve (12) inches to a point in my brick wall; thence S.  
 69° 30' E. eighty (80) feet to corner at back end of my brick  
 wall; thence in a line parallel with Main Street, N. 20°  
 30' E. twelve (12) inches to corner on *A. L. Mills'* property, thence
