Now, Know All Men By These Presents, That The Fountain-inn Oil and Manufacturing Co. of said County and State, in consideration of the premises and the sum of Five & no/100 Dollars to me in hand paid by the said Enoree Power Company, the receipt whereof is hereby acknowledged, have granted, bargained, sold, released and conveyed, and by these presents do grant, bargain, sell, release and convey unto the said Enoree Power Company, its successors and assigns, the right, privilege and easement to go in and upon the tract of land situated in said County and State, bounded by lands of on North Stewart Jones, West by Main Street and to construct and maintain in, upon, along and through said premises in a proper manner with poles, towers, wires, conduits and other necessary apparatus and appliances, a line ^{or lines} for the purpose of transmitting power by electricity aforesaid, and also to construct and maintain in, along and through the said premises with poles, wires, etc., a telephone line or lines, together with the right, at all times, to enter upon said premises for the purpose of inspecting said lines and making necessary repairs and alterations thereon; together with the right to cut away and keep clear of said lines all trees and other like obstructions that may, in any way, endanger the proper operation of the same.

It is agreed that in case we make any improvement it becomes necessary to move poles to some place on this lot, we do so by having 30 days notice in writing.

To Have And To Hold, all and singular the rights, privileges and easements as aforesaid in, to and upon said premises, unto the said Enoree Power Company, its successors and assigns.

League of said County and State, in consideration of the premises and the sum of Five Dollars to me in hand paid by the said Enoree Power Company, the receipt whereof is hereby acknowledged, have granted, bargained, sold, released and conveyed, and by these presents do grant, bargain, sell, release and convey unto the said Enoree Power Company, its successors and assigns, the right, privilege and easement to go in and upon the tract of land situated in said County and State, bounded by lands of F.C. Thompson Est of Alice Brooks, J.L. Smith, and to construct and maintain in, upon, along and through said premises in a proper manner with poles, towers, wires, conduits and other necessary apparatus and appliances, a line or lines for the purpose of transmitting power by electricity aforesaid, and also to construct and maintain in, along and through the said premises with poles, wires, etc., a telephone line or lines together with the right, at all times, to enter upon said premises for the purpose of inspecting said lines and making necessary repairs and alterations thereon; together with the right to cut away and keep clear of said lines all trees and other like obstructions that may, in any way, endanger the proper operation of the same.

In case any damage is done to crops in constructing said line the Enoree Power Co. will pay same provided written claim is made upon the said Power Co. within 30 days after such damage is done.

To Have And To Hold all and singular, the rights, privileges and easements as aforesaid in, to and upon said premises, unto the said Enoree Power Company, its successors and assigns.
