Now, Know All Men By These Presents, That I, F.M. Todd of said County and State, in consideration of the premises and the sum of Three Dollars to me in hand paid by the said Encree Power Company, the receipt whereof is hereby acknowledged, have granted, bargained, sold, released and conveyed and by these presents do grant, bargain, sell, release and convey, unto the said Encree Power Company, its successors and assigns, the right, privilege and easement to go in and upon the tract of land situated in said County and State, bounded by lands of S.T. Moore, S.J. Wilson, Alex-Abercrombie and to construct and maintain in, upon and along, through said premises in a proper manner with poles, towers, wires, conduits and other necessary apparatus and appliances, a line or lines for the purpose of transmitting power by electricity aforesaid, and also to construct and maintain in, along and through the said premises with poles, wires, etc., a telephone line or lines, together with the right, at all times, to enter upon said premises for the purpose of inspecting said lines and making necessary repairs and alterations thereon; together with the right to cut away and keep clear of said lines all trees and other like obstructions that may, in any way endanger the proper operation of the same.

In case any damage is done to crops in conducting said line, the Encree Power Co. will pay same 'Provided written claim is made within 30 days after such damage.

To Have And To Hold all and singular, the rights, privileges and easements as aforesaid in, to and upon said premises, unto the said Enoree Power Company, its successors and assigns.

An ordinance authorizing the Enorse Power Company of South Carolina to construct and operate through the twon of Fountain Inn, South Carolina, line or lines of wires for the transmission of electricity for the purpose of furnishing light and power.

1. Be it ordained by the Town council of the Town of Fountain Inn, S.C., in Council assembled and by the authority of the same, that the Enoree Power Company of South Carolina, it's successors and assigns, be and is hereby authorized to construct, maintain, repair and operate through the Town of Fountain Inn, S.C., upon right of way heretofore granted by property owners within the said Town of said Company, line or lines of wires or other electric conductors, together with all necessary feeders and surface wires or other electric conductors to be used for the transmission of electricity for the purpose of furnishing light and power; the said line or lines of wire to be placed upon poles erected on said right of way, and authority and permission is hereby granted to the Enoree Power Company to cross Knight, Western and Main Streets of the Town of Fountain Inn, the Main Street crossing to be near the Fountain Inn Oil Mill.

II. That the work of erecting poles by virtue of this orbinance, shall be done under the supervision of the Town Council of the Town of Fountain Inn, S.D., and the said Encree Power Company shall replace and properly relay any side walk or street that may be displaced by reason of the erection of such poles, and upon failure of the Company so to do, after thirty days' notice in writing shall have been given by the Mayor of the Town of Fountain Inn, S.C. to said Encree Power Company, the Town of Fountain Inn may repair such portion of the side walk or street that may have been disturbed by said Company and collect the costs so incurred from the said Company.

III. In the event that at any time, should consider it necessary for the proper protection of life or property of the citizens or other to have such netting or support placed under the transmission wires of the said Power Company as shall be deemed sufficient to afford the said protection, the Encree Power Company, upon the request by the Town Council that such be done, shall provide such netting and support and place the same under it's wire; and the said Company shall at all times be subject to the Town ordinances now in existing, or which may be hereafter passed relative to the use of the public streets of the said Town by electric, telegraph or telephons

IV. The said Encree Power Company of South Carolina shall indemnify the Town of Fountain Inn, S.C. against, and assume all liability for, damages which may arise or accrue to the Town of Fountain Inn, S.C. from any injury to persons or property from the doing of any work herein authorized, or the neglect of the said Company, or any of it's employees, to comply with any ordinance relative to the use of the Streets of said Town and to the construction, maintenance and operation of it's line in and through the Town of Fountain Inn, S.C., and the acceptance by the said Power Company of this ordinance shall be an agreement by it to pay to the Town of Fountain Inn, S.C. any sums of money which the Town may become liable from or by reason of such injury.

V. The said Enorse Power Company of South Carolina shall file with the Clerk of the Council of the Town of Fountain Inn, S.C. it's acceptance of this ordinance within thirty days of its passage and the same shall be in full force when signed by the Mayor and Clerk of the Town Council of the Town of Fountain Inn, S.C. and accepted by the Enorse Power Company.
